With reference to the first item on the agenda of the Shareholders' Meeting, the Board of Directors intends to submit for your approval, in accordance with the law, the draft financial statements as of 31 December 2025 (consisting of the income statement, statement of financial position, cash flow statement, statement of changes in shareholders' equity and explanatory notes), accompanied by the related report of the Board of Directors on operations.

These documents, together with the consolidated financial statements as at 31 December 2025, including the consolidated sustainability report, the report of the Board of Statutory Auditors drafted pursuant to Article 2429 of the Italian Civil Code and the report of the independent auditors EY S.p.A. on the financial statements and consolidated financial statements as at 31 December 2025, will be made available to the public at the Company's registered office, on the website www.ferrettigroup.com, on the website of Borsa Italiana S.p.A. and on the authorised storage mechanism "eMarket Storage" at www.emarketstorage.com.

The Company's financial statements as of 31 December 2025 show:

2. to pay, gross of any legal withholdings, a dividend per unit equal to Euro 0.11 for each of the Ferretti ordinary shares issued and outstanding on the ex-dividend date indicated below, with the ex-dividend date (so-called *ex date*), dividend entitlement date (so-called record date) and payment date (so-called payment date) on 15 June 2026, 16 June 2026 and 17 June 2026, respectively.
